We are able to offer you optimal exchange rates by removing the middle man and ensuring that our clients pay only the actual currency transaction costs.

You can use this service yourself, or we can combine it with our banking and payments service for a fully managed solution.

Please check out the standard rates available on www.ofx.com, and then compare them to the discounted rate that we have negotiated.

Through this service you will:

- save, typically, 3% of the value of transfers;
- avoid excessive commission rates;
- effect transfers on an average of 24 hours (instead of 3-4 days!);
- work directly with the currency dealers if you wish to;
- pay a flat 1% fee



CASE STUDY 1

Urgent International Transfers Required by Client

Our client needed to transfer substantial funds from US to UK but was struggling to set up a UK bank account in the timescale needed.

Our client was advised by their bank that costs would involve:

- 4 day transfer
- international bank charges
- 5% bank commission on the transaction

- no international bank charges
- 1% commission

CASE STUDY 2

US Corp required regular transfers of funds to Europe

FAQs

Q1. Is there a minimum transaction value?

No, the OFX charges are a flat 1% of any value of transaction

Q2. How will the new Foreign Exchange Service affect my current banking relationships?

This should have no effect. Briars will work with you to teach your teams how to use the service directly.

Q3. We receive monies on-line from overseas customers. Can we use this service to maximise on our savings?

Yes. Both incoming and outgoing foreign transfers can be booked through this service. By using this service, you remove most international bank charges; reduce many payment delays and, through Briars' relationship with OFX, achieve beneficial rates.

Q4. How much are the Briars fees?

We do not charge any fees for this service, but we do receive a small commission from OFX. We only charge for payment services where you ask us to carry out transactions on your behalf.



Q5. Our business is unable to use this service since it is tied into our corporate facility.

Some banks do try to lock you in to their other lucrative services, others do not, so ask! If you provide us with some of your recent transaction details we will provide you with our costs comparisons, enabling you to negotiate better rates with your lender.
